### What is Title I?

Matilda Harris Elementary School is identified as a Title I school as part of the Elementary and Secondary Education Act of 1965 (ESEA). Title I is designed to support state and local school reform efforts tied to challenging State academic standards in order to reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

## **School Plan for Shared Student Achievement**

What is it? This is a plan that describes how Matilda Harris Elementary School will provide opportunities to improve parent engagement to support student learning. Matilda Harris Elementary School values the contributions and involvement of parents in order to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Matilda Harris Elementary School will support parent engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

**How is it developed?** Matilda Harris Elementary School welcomes parent input and comments at any time regarding the plan. All parent feedback will be used to revise the plan for next year. The plan is posted on our school website for parents to view and provide feedback throughout the year. We also distribute an annual survey (online and paper sent home) that asks parents for their suggestions on the plan and the use of funds for parent involvement.

**What feedback was indicated?** The yearly survey showed that parents prefer information instead of workshops on improving math skills, reading skills, and on test preparation. Parents also prefer workshops held in the afternoon and evening over morning and lunch times. Activities will be planned to address these needs during the 2016-17 school year.

**Who is it for?** All students and their families are encouraged and invited to fully participate in the opportunities described in this plan. Matilda Harris Elementary School will provide full opportunity for the participation of all parents, including those with limited English, parents of students with disabilities, parents of homeless and migratory children, as well guardians of neglected or delinquent children.

**Where is it available?** Once adopted, the plan is posted on the school website, in the parent resource center, and in the front office.



### 2016-2017 District Goals

- -To increase Math GMAS (Georgia Milestones Assessment System) performance at the elementary (53% to 56%), middle (43% to 46%), and high school (56.5% to 59.5%) levels.
- -To increase ELA GMAS performance at the elementary (45% to 48%), middle (42% to 45%), and high school (50% to 53%) levels.

### 2016-2017 School Goals

- -Increase the percentage of students in the proficient and distinguished levels (3-4) from 48% to 51% on the 2017 ELA GMAS for grades 3-5.
- -Increase the percentage of students in the proficient and distinguished level from 56% to 59% on the 2017 Mathematics GMAS for grades 3-5.
- -Increase the percentage of students in grade three scoring a 650 or higher Lexile from 56% to 59% on the 2017 GMAS.
